IN THE COURT OF THE THIRD JUDICIAL CIRCUIT IN AND FOR MADISON COUNTY, FLORIDA  
AFFIDAVIT FOR ORDER TO SHOW CARE

BEFORE ME, Wetzel Blair, Judge of the above captioned court, in and for Madison County, Florida, personally came Animal Control Officer Jamie Willoughby of the Madison County Animal Control, who being duly sworn, deposes and says that affiant has probable cause to believe that certain care has not been afforded to the cats residing on or about a certain premises or curtilage thereof, or that evidence relevant to proving, care has not been appropriate to the animals described in or on certain premises 711 Benchmark Drive, Lee, Florida also known as the Caboodle Ranch, in Madison County, FL being known and described as follows:

1. Three hundred (~~300~~)<sup>100</sup> to five hundred (~~500~~)<sup>200</sup> cats

Said property is occupied by or under the control of a Craig Grant, owner of the Caboodle Ranch and there is now being kept in or about the property cat(s) which were residing within deplorable conditions with a high percentage of the cats suffering from an unknown respiratory illnesses with other illnesses and/or disorders.

Mr. Grant has transported cats to the veterinary clinic for evaluation but refuses to follow the recommendations of humane euthanasia allowing the cats to suffer a possible painful death and/or infect the remainder of the cats when returned to the ranch.

Attached are statements of Laura Bevan, Director of the Humane Society of the United States, Jamie Willoughby, Animal Control Officer of Madison County and photographs for perusal demonstrating the condition of the animals and the need for compliance within thirty (30) days for Mr. Grant to resolve the following but not limited to within the thirty (30) day period:

- 168
- 1) All husbandry and medical instructions from veterinarian of his (Grant) choice
  - 2) Initial number of cats (intake paperwork, money's received, etc or if applicable)
  - 3) Accounting of all cats that are removed and relocated to include date, name of agency
  - 4) Complete medical records of all treated cats during those thirty (30) days including veterinary findings and recommendations, treatment given, etc; not just veterinary receipts
  - 5) Record of any cats that die during that thirty (30) day period, including euthanasia
  - 6) If not comply with recommendation, such as euthanasia, he (Grant) must show that the cat was taken to another veterinarian for treatment/hospitalization. This includes the cat has to be treated by a veterinarian or hospitalized within twenty-four (24) hours.

If compliance is not met within the specified time frame, appropriate action will be taken for the health and welfare of the animals.
