SHERIFFS OF THE STATE OF FLORIDA:

Having received and considered the sworn affidavit of TINA DEMOTSIS,
dated 02/24/2012, said affidavit alleging:

COUNT 1: CRAIG A. GRANT on or between September 6, 2011, through February 1, 2012, in MADISON County, Florida, did then and there intentionally and unlawfully commit an act to any animal to wit: the BLACK and WHITE CAT NAMED "LILLY", which resulted in the cruel death or excessive or repeated infliction of unnecessary pain or suffering or caused the same to be done, contrary to Florida Statute 828.12.

COUNT 2: CRAIG A. GRANT on or about September 6, 2011, and continuing through on or about February 1, 2012, in MADISON County, Florida, did unlawfully and knowingly engage in a scheme to defraud as defined by Florida Statute 817.034(3)(d), by engaging in a systematic, ongoing course of conduct with the intent to defraud one or more persons to wit: the CAT OWNERS, by false or fraudulent pretenses, representations, or promises, or willful misrepresentations of future acts, and did thereby obtain property, to wit: the MONEY, of an aggregate value of less than \$20,000, the property of the: CAT OWNERS, contrary to Florida Statute 817.034(4)(a).

COUNT 3: CRAIG A. GRANT on or between September 6, 2011, through February 1, 2012, in MADISON County, Florida, did then and there unlawfully and unnecessarily overload, overdrive, torment, deprive of necessary sustenance or shelter, or unnecessarily or cruelly beat, mutilate, or kill an animal, to-wit: the BROWN TABBY CAT, the property of CRAIG A. GRANT, contrary to Florida Statute 828.12.

COUNT 4: CRAIG A. GRANT on or between September 6, 2011, through February 1, 2012, in MADISON County, Florida, did then and there unlawfully

and unnecessarily overload, overdrive, torment, deprive of necessary sustenance or shelter, or unnecessarily or cruelly beat, mutilate, or kill an animal, to-wit: the GREY CAT NAMED "GREY", the property of CRAIG A. GRANT, contrary to Florida Statute 828.12.

COUNT 5: CRAIG A GRANT on or between September 6, 2011, through February 1, 2012, in MADISON County, Florida, did then and there unlawfully and unnecessarily overload, overdrive, torment, deprive of necessary sustenance or shelter, or unnecessarily or cruelly beat, mutilate, or kill an animal, to-wit: the WHITE CAT NAMED "DUCHESS", the property of CRAIG A. GRANT, contrary to Florida Statute 828.12.

THESE ARE THEREFORE TO COMMAND YOU TO FORTHWITH ARREST AND BRING THE ABOVE NAMED DEFENDANT BEFORE ME TO BE DEALT WITH ACCORDING TO LAW.
