**VERIFIED PETITION FOR CUSTODY, CONTROL AND DISPOSITION
OF ANIMALS PURSUANT TO § 828.073, FLA.STAT.**

COMES NOW the Petitioner, the Hon. BEN STEWART, in his official capacity as the Sheriff of Madison County, Florida, (hereinafter the "SHERIFF") and files this petition against the Respondent, CABOODLE RANCH, INC., a Florida not-for-profit corporation, (hereinafter "CABOODLE RANCH"), Respondent, CRAIG A. GRANT, a/k/a CRAIG GRANT, individually, (hereinafter "GRANT") and Respondent, NANNETTE ENTRIKEN, a/k/a NANETTE ENTRIKEN, individually, (hereinafter "ENTRIKEN") (CABOODLE RANCH, GRANT and ENTRIKEN may be referred to herein collectively as the "RESPONDENTS") and alleges:

1. This is an action for the custody, control and disposition of animals pursuant to § 828.073, Fla.Stat. This court has jurisdiction over this matter pursuant to § 828.073(2), Fla.Stat.

2. All conditions precedent to the bringing of this action have been performed by the SHERIFF or have otherwise occurred.

3. On or about February 27, 2012, the SHERIFF seized and took custody of certain animals (hereinafter the "ANIMALS") pursuant to a court order so authorizing and directing the SHERIFF to do the same. A copy of such order is attached hereto as Exhibit "A".

4. At the time the ANIMALS were seized by the SHERIFF, the ANIMALS were found in Madison County, Florida.

5. The SHERIFF presently has custody of the ANIMALS and is providing housing, feeding, veterinary treatment and other care for the ANIMALS through his agreement with the American Society for the Prevention of Cruelty to Animals, Inc., a New York not-for-profit corporation with a mission to provide effective means to prevent cruelty to animals throughout the United States (hereinafter the "ASPCA").

6. Costs have been incurred, and are continuing to be incurred, in caring for the ANIMALS while in the custody of the SHERIFF and his agents.

7. A portion of the ANIMALS are listed on Exhibit "B" attached hereto with the remainder of the ANIMALS listed on Exhibit "C" attached hereto. (That portion of the ANIMALS listed on Exhibit "B" shall be referred to herein as the "CABOODLE RANCH ANIMALS.") (That portion of the ANIMALS listed on Exhibit "C" shall be referred to herein as the "ENTRIKEN ANIMALS.")

COUNT I
CABOODLE RANCH ANIMALS

8. The SHERIFF realleges the allegations of paragraphs 1 through 7 above.

9. At the time they were seized, the CABOODLE RANCH ANIMALS were the property of the CABOODLE RANCH and remain so pending disposition by the court.
10. GRANT is an officer and director of CABOODLE RANCH.
11. Upon information and belief, GRANT may claim an interest in some or all of the CABOODLE RANCH ANIMALS.
12. Both CABOODLE RANCH and GRANT are not able to provide adequately for the CABOODLE RANCH ANIMALS and/or are not fit to have custody of the CABOODLE RANCH ANIMALS.

COUNT II
ENTRIKEN ANIMALS

13. The SHERIFF realleges the allegations of paragraphs 1 through 7 above.
14. At the time they were seized, the ENTRIKEN ANIMALS were the property of ENTRIKEN and remain so pending disposition by the court.
15. ENTRIKEN is not able to provide adequately for the ENTRIKEN ANIMALS and/or is not fit to have custody of the ENTRIKEN ANIMALS.

VERIFICATION

PURSUANT TO SECTION 92.525, FLORIDA STATUTES, UNDER PENALTIES OF PERJURY, I DECLARE THAT I HAVE READ THE FOREGOING PETITION AND THAT THE FACTS STATED IN IT ARE TRUE.

DEMAND FOR RELIEF


WHEREFORE, the SHERIFF demands the court to:

- A. Schedule, by written order, a hearing on this petition, to be held within 30 days after the commencement of this action, to determine all of the matter raised in this petition and § 828.073, Fla.Stat.
- B. Order that a copy of order setting the above hearing, and a copy of this petition, be served on the RESPONDENTS in conformance with Chapter 48, Fla.Stat., and that such service shall constitute service of process on the RESPONDENTS as contemplated by Florida law.
- C. After holding the above hearing, find that the RESPONDENTS are not able to provide adequately for the ANIMALS and/or are not fit to have custody of the ANIMALS and order that the RESPONDENTS' rights in the ANIMALS shall be forever terminated and that the ANIMALS be turned over to the SHERIFF to be disposed of as he sees fit, or turned over to the ASPCA to be disposed of as it sees fit.
- D. After holding the above hearing, enjoin the RESPONDENTS from having possession or custody of other animals. Such injunction should provide that it is subject to change, modification or termination, upon the petition of the RESPONDENTS and when warranted by evidence that RESPONDENTS can properly assume the care of animals in a responsible manner.
- E. After holding the above hearing or after holding a subsequent hearing, determine and order that the RESPONDENTS shall pay the costs incurred in caring for the

ANIMALS while in the custody of the SHERIFF and his agents.

- F. Granting to the SHERIFF and his agents such other and further relief as the court deems just and proper.

SEARCH WARRANT

IN THE NAME OF THE STATE OF FLORIDA, TO MADISON COUNTY
SHERIFF BEN STEWART, OR ANY OF HIS DULY CONSTITUTED AGENTS:

WHEREAS a complaint on oath, and in writing, supported by Affidavit has
been made before me by INVESTIGATOR TINA DEMOTSIS of the MADISON
COUNTY SHERIFF'S OFFICE.

AND WHEREAS said facts made known to me have caused me to certify
and find that there is probable cause to believe that certain laws have been and
are being violated in or on certain premises and the curtilage thereof, in Madison
County, Florida, being occupied by and under control of CRAIG A. GRANT
and/or NANNETTE ENTRIKEN and being further known and described as
follows:

BEGIN AT THE INTERSECTION OF US 90 AND COUNTY ROAD (CR)
255/MAIN STREET. TURN LEFT ONTO CR 255/MAIN STREET AND TRAVEL
SOUTH APPROXIMATELY .9 MILES TO SOUTHEAST 85TH
AVENUE/SOUTHEAST BENCHMARK DRIVE. TURN RIGHT ONTO SE 85TH
AVENUE/SE BENCHMARK DRIVE AND TRAVEL WEST APPROXIMATELY 1.2
MILES AND ARRIVE AT 711 SE 85TH AVENUE/SE BENCHMARK DRIVE, LEE,
FLORIDA FOUND ON THE LEFT. THE PROPERTY TO BE SEARCHES
INCLUDES 6 PARCELS OF LAND APPROXIMATELY 5 ACRES EACH, PARCEL
#15-1S-10-1253-006-000, PARCEL #15-1S-10-1253-007-000, PARCEL #15-1S-10-
1253-013-000, PARCEL #15-1S-10-1253-014-000, PARCEL #15-1S-10-1253-015-
000, AND PARCEL #15-1S-10-1253-023-000 LOCATED IN LEE, FLORIDA.
PLEASE REFER TO THE MADISON COUNTY PROPERTY APPRAISER'S MAP IN
THE PACKAGE PROVIDED FOR A DETAILED LAYOUT OF THE PROPERTIES IN
QUESTION. THE PARCEL LOCATED AT 711 SE BENCHMARK DRIVE IS
PARTICULARLY DESCRIBED AS A TWO LEVEL WOODEN BUILDING, TAN IN
COLOR, WITH A BROWN SHINGLED ROOF. THE BUILDING IS LOCATED ON
THE SOUTH SIDE OF SE BENCHMARK DRIVE AND FACES TO THE NORTH.
THE DOUBLE FRONT DOOR OPENS OUT TO THE NORTH AND TO THE LEFT
AND RIGHT; THE DOORS ARE CONSTRUCTED OF PRESS WOOD WITH TAN
WOODEN PANELING COVERING THEIR OUTSIDE SURFACES. THERE ARE 2"
x 4" WOODEN PLANKS NAILED TO THE OUTSIDE SURFACE OF THE DOORS,
CREATING AN X.

And there is now being kept in or on said premises and curtilage thereof
certain property being described as follows:

1) LIVE OR UNBORN DOMESTICATED ANIMALS; 2) DECEASED ANIMALS, OR REMAINS OF DECEASED ANIMALS BOTH ABOVE AND BELOW GROUND; 3) ANY AND ALL RECORDS IN WRITTEN OR ELECTRONIC FORM PERTAINING TO THE CARE, HOUSING, FEEDING AND TREATMENT OF SAID ANIMALS; 4) ANY AND ALL RECORDS IN WRITTEN OR ELECTRONIC FORM PERTAINING TO THE SOLICITATION, RECEIPT AND/OR USE OF DONATIONS MADE TO CABOODLE RANCH, INC. OR TO CRAIG GRANT; 5) ANY AND ALL FINANCIAL DOCUMENTATION, INCLUDING BUT NOT LIMITED TO, STATEMENTS OF BANK ACCOUNTS, CREDIT OR DEBIT CARDS, CHECKS, CREDIT REPORTS, OR ANY OTHER DOCUMENTATION BEARING OR ASSOCIATED WITH THE NAME CABOODLE RANCH, INC. OR CRAIG GRANT; 6) ALL COMPUTERS, DIGITAL STORAGE DEVICES SUCH AS COMPUTER DISKS, CD ROMS, EXTERNAL DRIVES, CDs, DVDs, JUMP/THUMB DRIVES, CAMERAS, MOBILE PHONES; 7) ANY AND ALL ANIMAL OWNERSHIP RECORDS; 8) ANY AND ALL MEDICATIONS, SUBSTANCES AND SUPPLIES RELATED TO THE HOUSING, CARE, FEEDING AND TREATMENT OF THE ANIMALS CONTAINED THEREIN; 9) ANY AND ALL CAGES, BEDDING, OR OTHER ITEMS USED AS ENCLOSURES OR IN THE HOUSING OF ANIMALS CONTAINED THEREIN; 10) ANY AND ALL FOOD, FOOD RECEPTACLES AND CONTAINERS USED IN THE FEEDING OF THE ANIMALS; 11) ANY AND ALL TOOLS, INSTRUMENTS, OR OTHER ITEMS USED TO MOVE, TRANSPORT OR BURY ANIMALS; 12) FIREARMS OR OTHER INSTRUMENTS USED IN THE DESTRUCTION OR EUTHANIZATION OF ANIMALS; 13) ANY AND ALL PHYSICAL AND TRACE EVIDENCE OF THE CRIMES CURRENTLY BEING INVESTIGATED.

All of which is being kept in violation of the laws of the State of Florida, to-wit: CRUELTY TO ANIMALS, FLORIDA STATUTE 828.12; CONFINEMENT OF ANIMALS WITHOUT SUFFICIENT FOOD OR WATER, FLORIDA STATUTE 828.13; and SCHEME TO DEFRAUD, FLORIDA STATUTE 817.034.

NOW THEREFORE you are commanded, with such proper assistance as may be necessary, in the daytime or in the nighttime, or on Sunday, as the exigencies of the occasion may demand or require, to enter and search the aforesaid premises, outbuildings, vehicles and curtilage thereof for the property described in this warrant; and if the same or any part thereof be found, you are hereby authorized to seize and secure same, giving proper receipt therefore and delivering a duplicate copy of this search warrant to the person in charge of the premises, or in the absence of any such person, leaving a duplicate copy on said premises, and making a return of your doings under this warrant within the (10) days of the date hereof, and you are further directed to bring said property so sound and also the bodies of the persons in possession of said property before the Court having jurisdiction of this offense to be disposed of according to law. You are hereby authorized to deliver said animals to an appropriate animal

housing facility for the health evaluation, examination, and treatment by a veterinarian(s). With respect to animals seized pursuant to this warrant, they shall be delivered into the custody of the Madison County Sheriff's Office or its designated agents where the animals shall receive necessary housing, veterinary and other care, or if voluntarily surrendered in writing to the Madison County Sheriff's Office, the animals shall be held or released as directed by the State. A written inventory of the animals (including descriptions, identifying information and location) shall be returned to the court along with the return for other evidence seized pursuant to this warrant.

The status of the animals seized pursuant to this search warrant shall also be subject to any other lawful court order issued with respect to their custody, legal status, cost of their care, or disposition.




